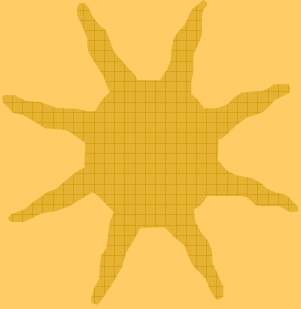

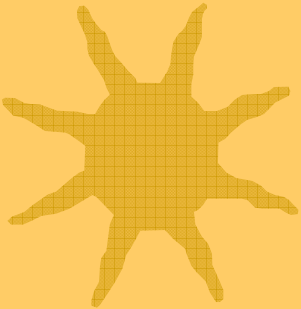

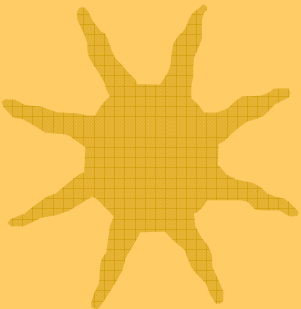
California is aging rapidly...



★ Life expectancy in CA is 1 yr. longer than in the nation as a whole



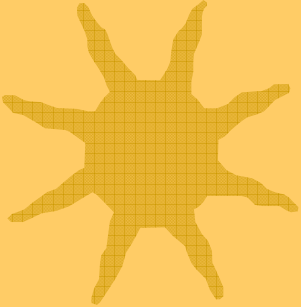
★ We now have approximately 4,000,000 people over age 65 – the largest older adult population in the nation



★ This number will double over the next twenty-five years due to the retirement of the baby boom generation.

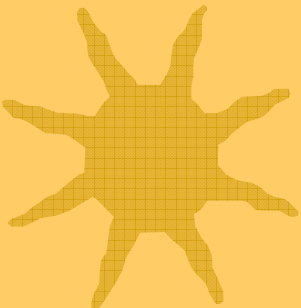

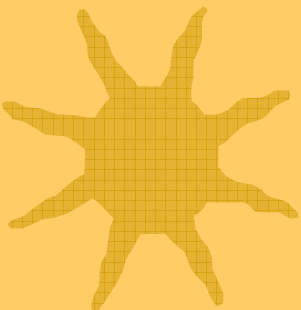


★ **As the population ages we can expect enormous changes that will sharply affect**

- Allocation of public resources

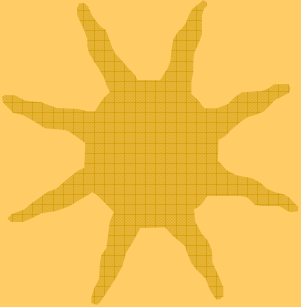


★ **During the next 6 to 8 years California faces the challenge of preparing for these changes**

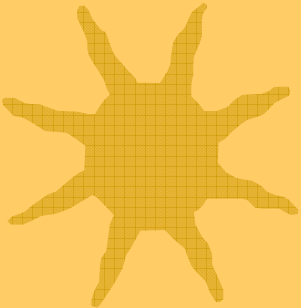




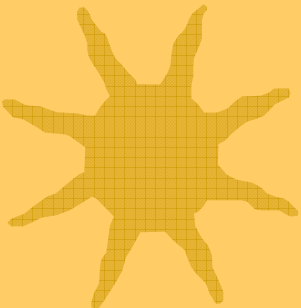
To Address This Situation...



★ Senate Bill 910 (Ch.948/99, Vasconcellos) required the California Health and Human Services Agency to develop a statewide strategic plan for long-term planning purposes.



★ The bill required University of California to conduct research to support plan development. CPRC produced 10 position papers and 2 statistical analyses



- ★ The bill asked the Agency to seek the advice of:
- The California Commission on Aging
 - The California Council on Gerontology and Geriatrics
 - Consumers and other stakeholders



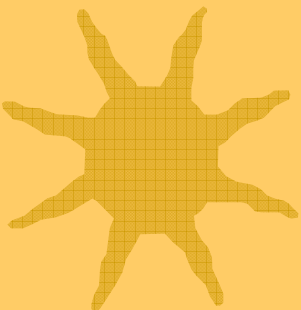
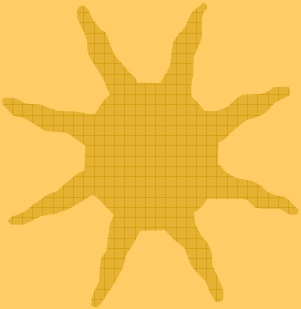
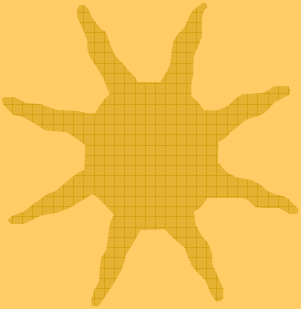
The Plan Development Process

★ **Plan Development Task Team...**

- Composed of Key Stakeholders
- Representing the perspective of a broad range of consumers
- Continuously supplemented by expert advisors
- Provided vision and ideas
- Developed **321 priority policy/action recommendations** in 17 categories and 289 less urgent recommendations

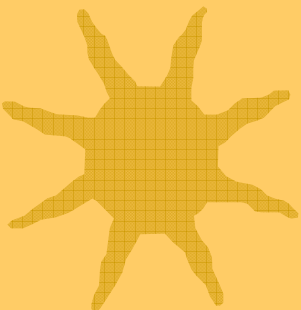
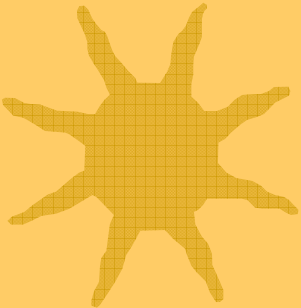
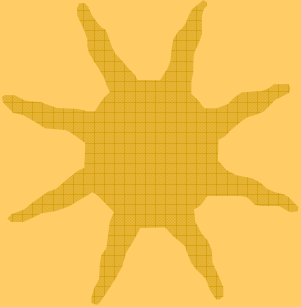


Then the work began ...

- ★ California Commission on Aging (CCoA) assumed responsibility for:
 - Monitoring implementation progress
 - Convene stakeholders to receive progress reports
 - Directly monitor progress of top priority action items
 - Updating the plan to reflect changing priorities and actions
 - Reporting to the legislature on the progress of implementation on a bi-annual basis



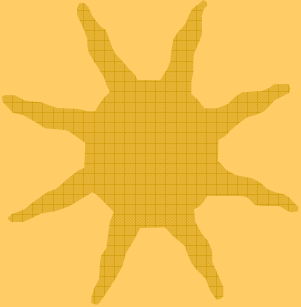
And to Date the CCoA ...



- ★ Encouraged and facilitated work on Strategic Plan implementation by:
 - Convening 9 new stakeholder task teams
 - Facilitating initial meetings of new teams
 - Establishing partnerships with two previously formed stakeholder teams
- ★ Is dialoguing with state officials at the March 8, 2005 Forum on the top 15 priorities in the Strategic Plan
- ★ Distributed a questionnaire and compiled results to get baseline on the Strategic Plan's top 15 priorities.
 - Questionnaire went to private, public and non-profit providers and aging advocates
- ★ Is writing the report for the Legislature on the progress of the Strategic Plan, to be presented in May 2005

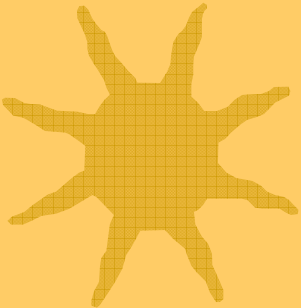
